

Measure 3: Candidate Competency at Program Completion (R3.3) - Summary

The EPP tracks and monitors the following Proprietary Measures from Education Testing Services (ETS) for candidate competency at program completion. Candidates are considered program completers upon successful completion of the Praxis Elementary Education Content Knowledge Test for Reading and Language Arts, Math, Science, and Social Studies and Praxis Principles of Learning and Teaching Exams. Below are the Licensure Exam Pass Rates for Program Completers for the combined three years (2021-22, 2022-23, and 2023-2024). For the three academic years, the number of completers is less than 10. Therefore, to protect the confidentiality of the completers the combined three-year average is provided.
